6	Campaigns Pot	<p>SJ gave an update on the remaining funding in the campaigns pot.</p> <p>1) Application for £600 for Drugs Testing Kits from Adam Goldstone</p> <p>AG updates the group on the progress of the Drugs priority campaign, and the rationale behind the drugs testing kits. There are various suppliers and types of drug testing kits, ranging widely in price. Most use a variety of chemical reagents which react with various compounds and are designed to give an indication of the makeup of a compound such as a white powder, which could be anything.
